Final Comments & Questions

The author is to be congratulated on her fine skill as a writer and her ability to depict the snow globe reality of J.K. Rowling's magical world. I wish perhaps the author were able to uncover even more about Rowling's own teaching career as that might be on way to connecting the fictional world with the actual world of pedagogy. As it stands now, this diploma work is a sort of vast and intricate horoscope in which the reader may find what type of teacher he resembles, be it Binns, or and Snape, or more likely Dumbledore, but also like a horoscope the real world application is nebulous at best. I feel the work should be more argumentative and the conclusion clearly demonstrates the author has a hard time making this project really useful for teachers. Recently Introduction to Philosophy textbooks have discarded the classic texts of Plato and Descartes in favor of using *The Simpsons* or *The Matrix* to fully explore issue of epistemology, ontology, and metaphysics. I wonder if it is possible to use the world of Harry Potter is such a away, but the inherent practicality of methodology will make it something of a challenge. Also, does the author examine the idea that popular teachers are not always good teachers and vice versa? Again, I must restate the lack of secondary sources is a big problem in this thesis no matter how fine the writing is, and more of them would have helped to push the author into a real world application.
