There is clearly a greater potential for further research than could actually be carried out, but the author's enthusiasm for her chosen field of research is obvious and makes this work special. I have just a question based on the theoretical part. Thom Gunn and Philip Larkin are quoted as examples of poets who could rise the interest of students in poetry, did you have a look at their poetry yourself? Do you think that some of it could be used even for non-native speakers? An "accessible" form of poetry may be found also in song lyrics, perhaps this type might be added to the list of still surviving forms of poetry.
