As representer and representative of an older style of masculinity, Hemingway was attracted to anything but the older style of woman. How does that help us read his work? What are the implications for

## Final Comments & Questions

As supervisor, I have mixed feelings about the submission of this thesis. While the student displays much ability along the way (use of a wide range of secondary sources, familiarity with Hemingway's fiction, a healthy critical engagement with gender debates around his work), because of external distractions he was not able to make deadlines, and thus I was not able to see and approve the final version before submission. Although I worked with several versions of chapter 3, which is the core of thesis, I did not see chapters 1, 2 and 4 at all.

This resulted in the less satisfactory state of the Introduction and chapter 2 (see my note on ch. 4 above). Also, the formatting of the Works Oted is incorrect. Despite my instructions, there is no List of Abbreviations. Generally, the work is poorly copy-edited. It is frustrating to encounter these shortcomings, because it is evident that the student could have produced an excellent work had he given more time and attention to it.

I recommend the grade 3 (dobře).
