The Introduction of the work presents the conception and the lay-out of the thesis. The following chapter Theoretical Background presents relevant theoretical background referring to this type of method – from the point of view of teaching as well as learning. It considers individual aspects of the implication of this method in the process of language acquisition and provides theoretical descriptions of individual tasks in TBLT. This chapter provides a sufficient theoretical basis for the actual research, which is described and commented upon in the following parts of the thesis.

The actual research is described and the results of the observation are provided in an easy-to-follow way by means of graphs and verbal commentaries (from my point of view, it is unnecessary to include the pages with individual graphs at the beginning of the thesis, they are quite sufficient in the Chapter IV Results and Commentaries).

The chapters Implications and Conclusions then prove the author's ability to work with linguistic material, analyze the data obtained from the research and synthesize them, as well as draw relevant and objective conclusions.

From the formal point of view, the thesis is at a high level; it meets all the requirements put on a piece of academic writing, and can be considered successful. (suggested evaluation: "výborně")
