More generally, the student makes little or no attempt to deal with social histories of the nineteenth century.
3.	The author carefully analyzed the information collected and drew appropriate and inventive conclusions supported by evidence. I propose that the examining board considers whether a work should be passed if it does not meet these requirements.

## Final Comments & Questions

This is an interesting and ambitious thesis, which has many excellent moments of insight. The student has done well with a wide range of material. However, I do have several reservations (expressed above). I would have otherwise recommended a grade of 1, but I propose to drop this by one grade because of these problems. Therefore I recommend a grade of 2 (velmi dobře).

In addition to the points above, I would like to hear the student's response to the following issue. At several points in the text, the student considers at length whether the given writer derived his or her fiction from autobiography. I do not see the relevance of the question. Surely the works can be considered as social commentary regardless of whether they were completely invented or not. Arguably Dickens's most effective fiction – A Christmas Carol – had no roots in the author's own family background or upbringing. Could the student explain the relevance of this material to the topic under consideration?
