Final Comments & Questions

The topic of the work has been attractive for all the time since the event. People all over the world got somehow involved in the thing, at least through the natural sympathy towards the USA, or through the strength of the attack, causing a feeling of the global danger. These facts make a good starting point for the thesis, in which the potential reader is prepared to obtain some important answers, or at least to be offered the author's (original) personal approach to the matter.

I do not think that this expectation has been fully met in this case. Even though an effort to get and process a fairly large amount of information from various and numerous sources is obvious, what remains as the strongest impression is that of prevailing descriptiveness of the work. This evaluation of mine can be best illustrated by the initial sentence of the Conclusion: "The goal of this thesis was to write about an important moment in the US history..." Yes, something like this (to write about...) has been fulfilled; but it rather gives the impression of a (even if quite rich) collection of facts and opinions, and I cannot get satisfied with such a low ambition on the level of bachelor's work. I would definitely expect a more critical voice and a more profound immersion in the case, resulting in a more distinct conclusion.

The language of the work is not bad, there is occasional uncertainty in the use of tenses in more complex contexts; it lacks in stylistic attractiveness; however, otherwise the text flows fluently, even if without much originality,

In summary, the thesis seems to be an average piece of work, not very inventive but still acceptable. The grade suggested: 3 ("dobře").
