## Final Comments & Questions

A classroom might be described as somewhere on a spectrum that includes a prison cell, a chapel and the dining room of a restaurant. While this thesis is concerned with the narrower category of language classrooms, some of the issues involved in these other institutional spaces arise.

Salutuory throughout is the criticism toward the older class arrangements; this opens a critical space for the consideration of new possibilities. The student employs a range of criteria with which to analyse the language classrooms of several schools in the Plzeň area and draws logical and intelligent conclusions. She is healthily suspicious of the claims of technology in these new environments, even as she (somewhat utopically) suggests the need for a lot of investment in this area.

Perhaps the analogy with restaurants brings to the fore the difficulty involved in the analysis of language classrooms. The balance of factors that lead to success or failure is similarly hard to break down (lighting, location, décor, price, service, food, furniture, etc.). The student then is to be saluted for broaching such a complex subject and proposing a range of tools for analysis. I recommend the grade of 1/výborně.
