Final Comments & Questions

In the Introduction, the author clearly states the two research questions, and the reader is well informed of the overall structure of the thesis. She partly opens a considerable number of subtopics and concepts. As a result, the impression that is given as early as in this introductory part is accessibility and clarity of the style. In the Theoretical Chapter, the author proceeds from the most general relevant notions over more specific characterisations, ending with a detailed presentation of all types of imperatives including the most special ones. The whole chapter is written in a very good academic style, and the author's appropriate involvement is obvious.

In the Method subchapter of the practical part, the process of selecting linguistic material is clearly described and the particular choice is explained. Furthermore, the author specifies all the aspects of the research she used in the analysis of individual excerpts, promising a complex package of linguistic characteristics of the given items. And subsequently she really provides the reader with a really rich survey of carefully analysed findings organized in a regular system, which makes the work excellently clear and accessible.

Finally, the author presents all the results, which is not a mere statistics of the occurrence of various types, but it is at the same time a well-written summarisation and commentary on the overall situation in terms of the linguistic sample used for the research. In addition, we get a perfect complete conclusion including a number of well-compiled graphs.

The whole work is marked by a high level of stylistic, grammatical and overall linguistic correctness and appropriateness; it is really comfortable to read, and, last but not least, it is very rich in information.

In summary, the present thesis is an excellent piece of academic work.
