Final Comments & Questions

The author's choice of topic is an excellent combination of her linguistic interests and knowledge on the one hand, and her profound enthusiasm in films and their language. The work is very well organized; it has a clear structure and fulfils all the requirements for both, the format and the style and content.

The aims and layout of the work are described in the Introduction chapter; the choice of material seems well-balanced as for variants of English.

The theoretical part is a very good base for the presentation of the analysis and results. It covers theoretical knowledge necessary for understanding the practical part, going from the most general areas (lexicology, semantics, lexicography) to those even more specifically relevant within the topic (theory and methods of translation). The Method chapter introduces the material and informs on the way of research presentation.

I appreciate the method in the analysis, where the author comments in detail on each individual phrase and offers evaluations of both sources – professional and amateur. This is especially interesting for a Czech native person who learns English, and I can imagine possible utilisation of the material in teaching English to Czech learners. The work is really rich in information, it is neatly organized and linguistically correct.

In the Conclusion, the author summarises the research and its results; I like her commentary on the different attitudes by professional and amateur translators. In addition, one of the biggest values of the work is that the research does not only bring a mere statistical summary, but also a competent evaluation of the results.
