Ideas are richly supported with accurate details that develop the main point. The author's voice is evident. 5.	Conclusion effectively restates the argument. It summarizes the main findings and follows logically from the analysis presented. 7.	The language use is precise. The student makes proficient use of language in a way that is appropriate for the discipline and/or genre in which the student is writing. 8.	The thesis meets the general requirements (formatting, chapters, length, division into sections, etc.). References are cited properly within the text and a complete reference list is provided. ## Final Comments & Questions

The main weakness of this thesis is its length – just about the minimum required – in combination with extensive digressive or not quite relevant parts. The topic offers a broad range of research, but unfortunately, the thesis comes short of its potential. Both main theoretical sources are valuable but should have been complemented by more (historical) sources. Extensive parts of the text just "recycle" information; especially the literary part would deserve more attention. The third part seems the weakest, without true research, rather just an essayistic appendix. It is understandable that a BA student has little teaching experience to support the "methodological" section, but since it is not a compulsory component, it would have been a better choice to extend both preceding parts.

With respect to the above reservations, the suggested grade is good (3).

**Q:** On p. 16 the author writes: "The writer also provided a description of **many homes**, inside and out, which shows that home is not only a place to life but a place to work on, to put a personal stamp on it ..... It would be interesting to hear at least a few examples at the defence.
