The author of the thesis dealing with the use of biblical texts in EFL classes at lower secondary schools was able to focus on the individual aspects relating to the selected topic in great detail. The thesis covers the issue of language teaching, the use of literary texts in language teaching context and also the quite broad field of biblical texts and its use in the EFL classroom. Despite the detailed information the thesis is still clear, logically structure and comprehensible. With respect to the sudden change of conditions and the subsequent alteration of the research design, the research was well organized and conducted. The resulting education material might be an interesting source of inspiration for other teachers.
