## **Final Comments & Questions**

I admired this thesis and recommend the grade of **1/výborně**. In many respects, it is a model work as it draws well on various theories that were present in our BA program and applies them to a detailed reading of a central work of anglophone popular culture. It reveals the dynamics of intercultural dynamics with subtlety and granular attention. In dealing with a work of science fiction, the student is alert to the broader social and cultural context, which has changed the way in which Le Guin's work since its original publication. The two close readings of passages in *The Left Hand of Darkness* are perceptive and help illuminate the theoretical implications.

I am left, then, with nothing to criticize. I do, however, have a question for the student. How would she connect her interpretation of Le Guin's the issues of intercultural communication that she has encountered throughout her BA studies. Would she be able to compare it to other cultural genres?
