Final Comments & Questions:

This is a complex topic which was researched and written with enthusiasm and much effort. I appreciate the range of sources and amount of data the author collected. Indeed, I wish that our criteria were not so strict with respect to presence of the analytical component of the thesis. One way or another, there is still a scope for improvement. E. g. Instead of including a mere random list of Caribbean authors with a brief information, it would make more sense to look more closely at one or more of their works and analyze them on the background of the historical events mentioned. Still, providing a successful defence, it could be considered a very good thesis.
