## Final Comments & Questions

This bachelor's thesis focuses on a grammatical topic which can be found in most grammar books in a more o less detailed way. Modal verbs represent an extremely important part of morphology – they are irreplaceable means of language expression.

The chapter Introduction explain the principles and organization of the thesis in a brief and clear way. In the following chapter Theoretical background the author provides a number of individual explanations and descriptions of the term "modality". This step is very important from the point of view of the concept of the work and the author's attitude towards the issue. She mentions individual grammarians' opinions and their justification of their attitudes. She clearly states which of the viewpoints she will use in her research and explains why.

The main part of Theoretical background presents the role of modal auxiliary "may", which is the focus of her work (she briefly mentions its perfective form "might", but does not pay attention to it, since it represents an individual issue).

In the practical part – analysis, the author mentions the resource of her excerpts as well as the Czech translation. The analysis itself (to be found in Appendix) provides a detailed evaluation of the function of the verb phrases containing "may" from the description of their formal verbal categories to the main point – telling the type of modality suggested by them. The author also analyzed the possibilities of Czech translation of individual verb phrases (by means of the Czech equivalent modal, adverbs or other means of translation). The analysis is very precise and detailed. It shows the author's interest in the given topic and the care with which she approached the work.

The conclusions presented in the chapter of the same name are relevant, based on the results obtained from the analysis and supported by clear and understandable graphs.

From the point of view of the language, the work is at a very good level.

To sum up, this thesis fully meets all the requirements set for a bachelor's thesis. I consider it an excellent piece of academic writing.
