Final Comments & Questions

This undergraduate thesis deals with the attitude of Czech people to foreigners. The title of the thesis is "How do Czech People Perceive (Namely English Speaking) Foreigners?" but the thesis does not at all focus on English speaking foreigners but foreigners in general, so the title of the thesis does not relate to the text of the thesis.

Organization of the thesis is deficient. Conclusion is missing at the end of the thesis. The thesis represents a collection of many different ideas, and the parts of the thesis are not always connected in a logical manner.

Taking into consideration the author's hard work and enthusiasm and the comments stated above, the evaluation recommended is "good".
