The author is a strong writer and has a strong but gentle prose style that I much admire. The introduction clearly sets up the goals of the thesis and I am particularly interested in the political, anthropological, and intertextual (interfilmic—i.e. Samurai films/ Westerns) elements. Only looking over the conclusion I find it not quite so strong as in the introduction which gave me the feeling that maybe the author was a little tired at the end.
