## Final Comments & Questions

I hugely enjoyed this inventive and original thesis. Its surprising gambit is in the choice of the books to examine--*The Great Gatsby*, and two later works of hard-boiled fiction. There is a difference in genre here, as well as contemporary context, but the student acknowledges this before going on to make some excellent observations. My only criticism is the error in the title and throughout in the use of the term "modernism" to denote the period in question. "Modernism" properly refers to aesthetic practices in the period and not the socio-historical context.

Also, it would have been interesting for the student to consider the histories of Los Angeles and New York City in relation to the works examined here. The former underwent a phase of huge boom in the early to midtwentieth century, and in many respects Chandler is the chronicler of the interference of big business with municipal politics and policing. In any case, this is not a criticism, but merely an idea that could be discussed at the defence.

I recommend the grade of excellent.
